## Chemical Compatibility Information

Inline diaphragm type check valves, all types of filters, self-sealing check valves, ball type check valves, and spring loaded check valves are all products that can, and typically do, contain multiple types of different materials. The chemical compatibility of the whole product is limited to those chemicals which are compatible with all of the materials present in the product. Pneuline has compiled an extensive list of various chemical compatibility ratings for the different materials that we use to manufacture our products, and have provided a list of chemical compatibility ratings for each specific product based on the materials used in that product.

The rating system is as follows:

- **A = Excellent** -- *The product is fully compatible with the chemical and is recommended for continuous use within the normal operating parameters of the product (temperature, pressure, etc).*
- **B = Adequate** -- *The chemical causes a minor effect to the product, slight corrosion or discoloration, minor loss in performance or slightly shortened operating lifespan.*
- **C = Not Ideal** -- *The chemical has a pronounced effect on the product and will degrade it. Material softening, swelling, loss of strength, corrosion, and discoloration may occur. Use only for limited timespans and replace often.*
- **D = Severe Effect** -- *The chemical has a severe adverse affect on the product and will likely destroy it. Not recommended for use.*
- **N/A = No Data Available** -- *One or more of the materials in the product has an unknown compatibility with the chemical.*
